MEMORANDUM OF UNDERSTANDING (MOU) ON EXCHANGE OF STUDENT/STAFF/FACULTY BETWEEN

NORTH LAKHIMPUR COLLEGE (AUTONOMOUS)



AND

DARRANG COLLEGE, TEZPUR



This MEMORANDUM OF UNDERSTNADING (MOU) is made as of 22nd day of November, 2022 by and between North Lakhimpur College (Autonomous) Hereinafter referred to as "NLC") and Darrang College, Tezpur (Hereinafter referred to as "DC"). Each individually a "Party" or "Institution" and collectively the "Parties" or the "Institutions".

The two institutions shall seek to promote:

2.1. Faculty Exchange:

- a. The exchange of faculty to the mutual benefit of both institutions.
- b. Collaboration in teaching, research and development and consultancy studies in the field of mutual interest.
- The exchange of academic materials and publications.
- d. Conduct lectures
- e. Undertaking joint research.
- f. Attachment of staff for purpose of curriculum development and review, upgrading of teaching and research skills.
- g. Participation in Seminars, Symposium and other types of academic discussions.
- h. Co-supervising post graduate students.
- Conducting study tours and joint consultancy work.

"NLC" and "DC" agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a predetermined programme of study or research.
a. Exchange student(s) will be selected by mutual agreement between the home institution and host institution.

b. An exchange student(s) will continue to be treated as full-time student at his/her

c. An exchange student(s) will be considered as full-time "exchange" student at the

d. His/her programme of study at the host institution will be determined by mutual

e. The host institute will evaluate an exchange student's performance in each course or module, award a letter grade or marks, and issue a letter to that effect.
f. The home institutions may award to the exchange student(s) credits earned at host

his/her "interim" academic advisor(s) identified by the host institution.

f. The home institutions may award to the exchange student(s) credits earned at host institutions but only after the home institution has established correspondence

- between courses taken at the host instituition vis-a-vis those offered at the home institution.
- g. If an exchange student(s) has/have undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.
- h. If an exchange student(s) has/have undertaken research, then the home institution will take note of the performance evaluation and the technical "report", and take steps in accordance with its own procedures.
- "NLC" and "DC" agree to provide suitable accommodation and/or living expenses for student exchange.
- To avail travel expenses, students can apply for existing funding programs at their respective home institute.
- k. The exchange student(s) will pay tuition and other fees at their home institution.

2.3. Other Areas:

- a. To exchange information on research and educational programs.
- b. To exchange information on teaching, learning material and other literature relevant to their educational and research programs.
- c. To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein.
- d. To organize jointly seminars, conferences, training program or workshops on topics of mutual interest and to invite each other's faculty, student and staff to participate therein.
- e. To propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's faculty, student and staff to participate therein.

g. To use laboratory facilities in specific cases for a limited period.

h. To permit students, staff and faculty members to use library facility.

3. Coordination:

Each institute shall appoint one member of its teaching faculty to coordinate the programme on its behalf. Further a coordination committee consisting of a

NLC and DC welcome the establishment of this Memorandum for cooperation and jointly agree to the provisions as set out above.
