Election to the members of Darrang College Students' Union (DCSU) will be held on 10/09/2025 for the following Portfolios:

- 6. Sectional Secretary for Culture
- 7. Sectional Secretary for Debate & Discourse
- 8. Sectional Secretary for Arts & Crafts
- 9. Sectional Secretary for Gymnasium & Asanas
- 10. Sectional Secretary for General Sports
- 11. Sectional Secretary for Outdoor Games
- 12. Sectional Secretary for Indoor Games
- 13. Sectional Secretary for Boys' Common Room
- 14. Sectional Secretary for Girls' Common Room
- 15. Sectional Secretary for Social Service

The President portfolio shall be elected from FYUGP 3rd or 5th semester classes. The Vice- President, General Secretary, Assistant General Secretary and Sectional Secretary for Literature shall be elected from FYUGP 1st and 3rd Semester classes. Under articles 14 (b) of the Constitution of Darrang College Students' Union, female candidates are debarred from contesting for Sectional Secretary for Boys' Common Room and male candidates are debarred from contesting for Sectional Secretary for Girls' Common Room.

The entire election process will be completed as per the schedule displayed on the DCSU election notice board.

Under Article 14(a), (b) and (c) of the Constitution of Darrang College Students' Union -

- 1. D.C.S.U. election shall be by secret ballot by the regular students of the college.
- 2. Any student member of the Union, male or female, belonging to any faculty and section is eligible to contest and vote in the election subject to the provisions of the constitution.

3. As per Lyngdoh Commission Report -

- (a) The Contesting candidates should not be less than 17 years and exceed 22 years of age on 01/09/2025.
- (b) Candidates should not have any academic arrears in the year of contesting the election.
- (c) The candidates should not have a previous criminal record, that is to say he should not have been tried and/or convicted for any criminal offence or misdemeanor. The candidate shall also not have been subjected to any disciplinary action by the College / University Authorities.
- (d) Students, intending to contest, are hereby informed that the candidate shall have only one opportunity to contest election.

4. A student member of the Union shall be disqualified for candidature in the Election if -

- a) He/she is a casual student.
- b) He/she is a defaulter in the college.
- c) He/she seeks election for the president portfolio but does not belong to FYUGP 3rd or 5th semester.
- d) He/she seeks election for the Vice-president, General Secretary, Assistant General Secretary and Sectional Secretary for Literature but does not belong to FYUGP 1st or 3rd semester.
- e) Male student contests for the Sectional Secretary for Girls' Common Room and female student contests for the Sectional Secretary for Boys' Common Room.
- f) He/she contests for two or more portfolios simultaneously.
- g) He/she has contested in any past elections of D.C.S.U.
- h) He/she fails to deposit security money at the time of submission of nomination papers.
- i) He/she does not have 75% or more class attendance (Excluding MDC, VAC & SEC) as follows -

HS 1st year: 01-08-25 to 31-08-25 HS 2nd year: 01-08-25 to 31-08-25 FYUGP 1st semester: 01-08-25 to 31-08-25 FYUGP 5th semester: 01-08-25 to 31-08-25 FYUGP 5th semester: 01-08-25 to 31-08-25
