NOTIFICATION

Notification regarding implementation of the Regulations Governing Academic Mobility under the National Education Policy (NEP) 2020.

In pursuance of the provisions of the National Education Policy (NEP) 2020, the University Grants Commission (UGC) Regulations, the Curriculum and Credit Framework for Undergraduate Programmes (CCFUGP), the National Higher Education Qualification Framework (NHEQF), the National Credit Framework (NCrF), the Academic Bank of Credits (ABC) Framework, the relevant Notifications and Office Memoranda issued by the Government of Assam and the Directorate of Higher Education, Assam, and in exercise of the academic autonomy conferred upon Darrang College (Autonomous), Tezpur, it is hereby notified that the **"Regulations Governing Academic Mobility under the National Education Policy (NEP) 2020 (Including Multiple Entry–Multiple Exit, Lateral Entry, Re-entry, Horizontal Mobility, Vertical Progression and Credit Transfer for Undergraduate Programmes)"** have been duly approved by the Academic Council and the Governing Body of the College and shall come into force with effect from the **Academic Session 2026–2027**, unless otherwise specified.

The Regulations shall govern all matters relating to:

1. Multiple Entry–Multiple Exit (MEME);
2. Lateral Entry;
3. Re-entry after exit;
4. Horizontal Mobility;
5. Vertical Progression;
6. Credit Transfer through the Academic Bank of Credits (ABC);
7. Semester Placement;
8. Recognition of Prior Learning; and
9. Bridge Courses and Deficiency Credits,

for all Undergraduate Programmes offered by Darrang College (Autonomous), Tezpur in accordance with the applicable statutory framework.

All Heads of Departments, the Controller of Examinations, the Admission Committee, the IQAC, faculty members, administrative staff and students are directed to ensure strict compliance with the provisions of the said Regulations.

Any matter not specifically provided for in these Regulations shall be governed by the applicable provisions of the UGC, the Government of Assam, the Directorate of Higher Education, Assam and other competent statutory authorities, as amended from time to time.

This Notification shall take immediate effect.
