

POLICY DOCUMENT

FOR SCHOLARSHIPS /FREESHIPS/AWARD

1. GOALS OF AWARDING SCHOLARSHIPS / FREESHIP AND AWARD TO STUDENTS

- 1.1 In order to bring about inclusivity in providing education to all, the institute follows the policy of financially assisting (a) meritorious students coming from weaker economic background, (b) girl students and (c) all the other deprived social classes of the society and may provide them from time to time:
 - (i) Scholarships,
 - (ii) Tuition Waivers (Freeships),
 - (iii) Book and other Grants,
 - (iv) Free hostel facility

(as per the approval of the Academic Council of Darrang College)

1.2 In order to promote an outstanding or excellent academic performance as well as excellence in games and sports, cultural activities, participation in students counselling, participation and constructive leadership involving all-round overall performance, the Institute may award various scholarships, prizes, medals and awards either from its own funds or from funds obtained from other governmental or non-governmental sources.

2. INDICATOR FOR AWARDING SCHOLARSHIPS, AWARD TO STUDENTS:

- 2.1 The academic performance of a student will be taken into account based on his/her Cumulative Grade Points Average (CGPA) for evaluating the merit of a student for the consideration of an award of scholarship/Free Aid to him/her.
- 2.2 The criteria for selecting an economically weaker candidate for award of scholarship/freeship by the institute shall take into account his academic performance as well the maximum income limit of his/her parents. In the case of salaried individuals, full emoluments including all allowances, honorarium, bonus, special pay, etc. (exclusive of HRA, if any) received in a year shall be taken into account for computing the annual income of his/her parents.
- 2.3 In case of non-salaried individuals such as businessmen, land owners/ agriculturists and those that are self-employed, etc., the entire gross income shall be taken into consideration for computing the annual income.
- 2.4 While computing the total annual income, the income of both parents from all sources shall be taken into consideration for evaluating the income of parents.
- 2.5 Outstanding performance may be considered as the sum total of the performance of student in academics, social service, games and sports, cultural activities, and participation in constructive leadership in the community.
- 2.6 The Principal of the College shall have the final say in all matters relating to selection of the students for grant for scholarship, awards and other aids.

3. GENERAL GUIDELINES:

- 3.1 All scholarships, medals, etc. are liable to forfeiture/withdrawal partially or fully in case of misconduct or deliberate concealment of material facts by the award winner.
- 3.2 A student leaving the Institute on his/her own accord without completing the prescribed program of study may be required to refund the amount of scholarship received by him/her in that academic year.
- 3.3 No scholarships will be paid for the month subsequent to the one in which the student completes the examination of his prescribed course.
